The Clerk presented the Township Committee with a proposal from Shropshire Associates LLC for a traffic study on the intersection of Taylor and Three Bridge Roads for \$5,200.00

Seery introduced "RESOLUTION AUTHORIZING AGREEMENT FOR PROFESSIONAL SERVICES" known as R-45-2023.

Seery moved that this Resolution be adopted, which motion was not seconded and therefor fell. Seery noted that there had been a serious accident at that intersection involving a school bus and motor vehicle ten years prior. Subsequently a young child died as a result of his injuries. He felt that necessitated further investigation as to whether a 4-way stop would be warranted.

Bishop moved that this Resolution be adopted, which motion was seconded by Zeck and adopted upon a call of the roll.

The Mayor opened the meeting up to the public for comment. Resident Betty Coombs expressed her disappointment that a traffic study would not be done at the intersection of Taylor and Three Bridge Roads stating that a life was worth any price paid. Mrs. Coombs second issue was regarding appointments to the Land Use Board and wanting more of the younger generations placed on Township Boards. The Mayor responded that five of the thirteen member Board were of the younger generation. In her final statement, she informed the Township Committee that the Elmer Times news reporter, Miranda, had been involved in a serious auto accident and was in critical condition in Christiana Hospital.

There being no further business the meeting was adjourned to meet at the call of the Mayor.
